

Terms and conditions of the Euro Run competition 2012

The European Central Bank (ECB) is organising an online competition for children – the Euro Run game. The competition will be open from 1 January to 31 March 2012. Players must be aged between 9 and 12 and be resident in the European Union (excluding the Outermost Regions and the Overseas Countries and Territories) when they take part (i.e. on the date they submit their score). Children of staff and consultants working for organisations directly involved in the competition are not eligible to participate.

In order to compete, players are required to accept these terms and conditions, enter the code of the competition and register their full name, age and e-mail address. This information will be used only to contact the winners. If they wish, players may also authorise the ECB to contact them at a later date, via e-mail, to inform them of future competitions and/or events. No personal data will be passed on to third parties.

Competition scores are expressed in euro solely for the purposes of the Euro Run game and are not redeemable for cash.

The four players to submit the highest score will be contacted via e-mail and asked to provide the contact details of one of their parents or of their legal guardian, as well as proof of their age on the date they submitted their score. If a player cannot be contacted or is unable to provide proof of his/her age within five working days of receiving the e-mail, the player with the fifth highest score will be contacted (and so on, until four eligible winners have been identified). If any of the top four players are eligible but unavailable to take part in the Euro Run event in Frankfurt am Main in the second quarter of 2012 (date to be confirmed), or if their parent or legal guardian does not permit them to participate in the event, they will receive a *Euro School set* (including coloured pencils, a pencil, an eraser, post-its, a ruler, a mouse pad, a key ring, a t-shirt, a notebook and a pen set) and the player with the next highest score will be contacted (and so on, until four eligible winners have been identified).

The 96 players with the next highest scores (ranked from 5 to 100) will be contacted via e-mail and asked to provide proof of their age on the date they submitted their score, as well as a postal address, in order to receive a *Euro School set*. If a player cannot be contacted or is unable to provide proof of his/her age within ten working days of receiving the e-mail, he/she will no longer be able to claim his/her prize. In such cases, the ECB will not be held liable for any loss or damage that may arise.

In the second quarter of 2012 (date to be confirmed), the four eligible winners of the competition, along with their parent or legal guardian, will be invited to spend a weekend in Frankfurt am Main. The costs of economy class travel and up to two nights in a hotel will be covered by the ECB. During their stay, the winners will take part in an offline Euro Run game at the ECB. It will consist of four rounds, each lasting five minutes. The player who achieves the highest cumulative score will win a collection of coins from the 17 euro area countries (or a prize of similar value). The three runners-up will receive an ornamental €10 banknote (or a prize of similar value). Prizes may neither be redeemed for cash, nor exchanged or transferred. The ECB reserves the right to change the prizes without prior notice.



Prizewinners accept that their names may appear on the ECB's website and/or be announced at public events.

Players – or where applicable their parent or legal guardian – declare their consent to the processing and storage of their personal data. The personal data processed by the ECB can be accessed by data subjects in accordance with Regulation (EC) No 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data. The maximum period of storage of relevant data is 15 years, starting on the day when a portrait, photograph, video or any other representation of data subjects is taken or made. The data can be accessed by data subjects according to the modalities established to ensure respect of the rights of the individuals concerned.
